

Terms & Conditions

Enterprise License

These Terms and Conditions ("Terms") govern the purchase and use of market intelligence reports and related publications ("Reports") made available by Humanoid.Guide, Stavanger, Norway ("Humanoid.Guide") at <https://humanoid.guide>. They apply to all Reports sold under an Enterprise License unless a specific product states otherwise. By purchasing or accessing a Report, the purchasing entity (the "Licensee") accepts these Terms. No signature is required; these Terms take effect upon purchase.

In short (non-binding): everyone at your organization and its majority-owned affiliates may use the Report. You may store it on internal systems and quote it in internal documents. It may not be shared outside your organization or published.

1. License

1.1 Subject to payment, Humanoid.Guide grants the Licensee a non-exclusive, non-transferable, worldwide license for an unlimited number of employees, officers, and directors of the Licensee and its Affiliates ("Authorized Users") to download, store, reproduce, and use the Report for internal business purposes. "Affiliate" means any entity that controls, is controlled by, or is under common control with the Licensee, where control means more than fifty percent (50%) of the voting interest.

1.2 The Licensee may distribute the Report internally — by email and on intranets, document management systems, and internal knowledge bases — provided access is limited to Authorized Users and permitted advisers under Section 1.3, and may print copies in reasonable quantities.

1.3 Consultants, contractors, and professional advisers engaged by the Licensee may use the Report solely to provide services to the Licensee, under obligations no less protective than these Terms, and may not retain copies after their engagement ends. The Licensee shall use reasonable efforts to ensure compliance by its Authorized Users and advisers and shall promptly remedy any unauthorized use of which it becomes aware.

1.4 The Licensee may reproduce excerpts, figures, tables, and data points from the Report in internal strategy documents, board materials, and internal presentations, attributed "Source: humanoid.guide." Each purchase is governed by the version of these Terms in force at the time of purchase.

11. Governing Law

These Terms are governed by the laws of Norway. Disputes shall be resolved by the ordinary courts of Norway, with the district court having jurisdiction over Stavanger as the agreed venue.
