

Terms & Conditions

Single-User License

These Terms and Conditions ("Terms") govern the purchase and use of market intelligence reports and related publications ("Reports") made available by Humanoid.Guide, Stavanger, Norway ("Humanoid.Guide") at <https://humanoid.guide>. They apply to all Reports sold under a Single-User License unless a specific product states otherwise. By purchasing or accessing a Report, the purchaser (the "Licensee") accepts these Terms on behalf of the Authorized User. No signature is required; these Terms take effect upon purchase.

In short (non-binding): this license lets one named person use the Report in their work. The file may not be shared with anyone else. Organization-wide access is available under an Enterprise License.

1. License

1.1 Subject to payment, Humanoid.Guide grants the one (1) named individual identified at purchase (the "Authorized User") a non-exclusive, non-transferable, worldwide license to download, store, and use the Report for their own internal business and professional purposes. The Authorized User may keep copies on devices under their personal control and print one copy for their own use.

1.2 The license is personal to the Authorized User. Each additional user requires a separate license, or the Authorized User's organization may purchase an Enterprise License.

1.3 The Authorized User may reproduce brief excerpts — short passages, individual data points, or a single figure or table — in internal documents of their organization, attributed "Source: humanoid.guide," provided the excerpts do not substitute for access to the Report. External publication of any part of the Report requires Humanoid.Guide's prior written consent and attribution.

1.4 The Authorized User may use the Report with AI and productivity tools to support their own analysis, provided access to the content remains restricted to the Authorized User and the tools do not use the content to train models made available to others.

2. Restrictions

These Terms are governed by the laws of Norway. Disputes shall be resolved by the ordinary courts of Norway, with the district court having jurisdiction over Stavanger as the agreed venue; mandatory consumer venue rights remain unaffected.
